Cancellation policy: This agreement is effective as of the date signed and shall remain effective until the Event ends on 25 March 2016 or until terminated by either party. All requests for refunds must be in writing, received, and confirmed by the Battleship NORTH CAROLINA thirty (30) days prior to the event. Contracts cancelled up to thirty (30) days of the event will be issued a refund. The Battleship NORTH CAROLINA may terminate this agreement at any time by notifying the sponsor in writing or by email. Upon such termination, the Battleship NORTH CAROLINA shall return to the Sponsor that portion of the Sponsorship fee as set forth under Sponsorship Policies.
